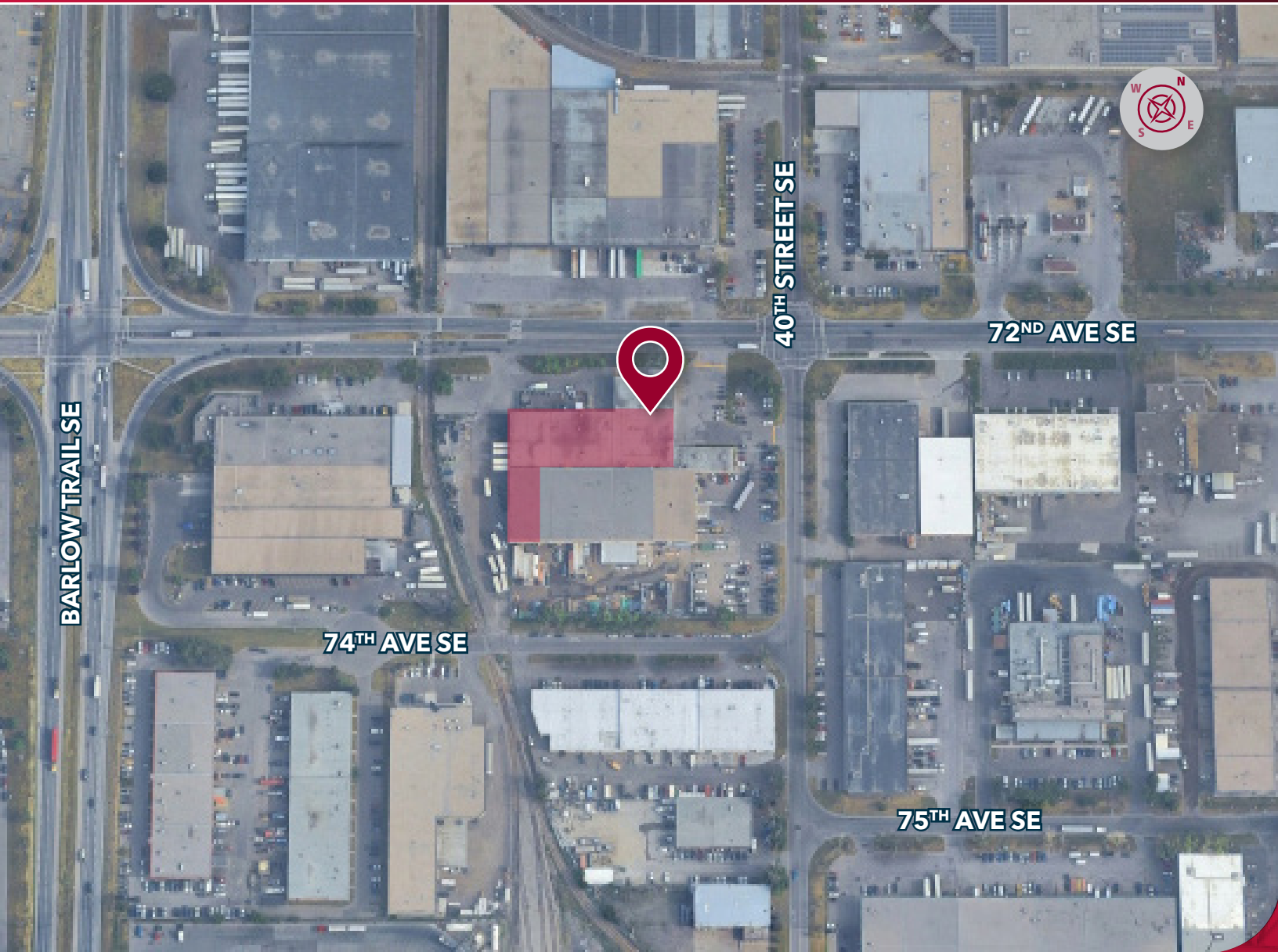
# MAIN FLOOR PLAN
